ELIGIBILITY

The Hispanic Studies Honors Theis is an independent research course that may be taken by Spanish majors in the Department of Hispanic Studies or majors in the International/Foreign Language International Economics (IS/FLIE) program specializing in Spanish.

To be eligible for this 3-credit hour course students must have completes between 15 and 18 hours in the major at the 300+ level. They must have a GPA of at least 3.5 in courses for the major and a 3.3 overall.

Prior to enrolling, the student must consult with a chosen faculty member within the Department of Hispanic Studies who will serve as Director of the Hispanic Studies Honors Thesis, SPA 497. The application includes:

A Research Project Contract

To be completed by the end of the previous semester by both the student and the Hispanic Studies faculty member who will supervise the project. The Research Project Contract may be downloaded from the Department's webpage.

A Proposal of Honors Thesis

(including its title and outline) to be approved by the Director of the thesis project, the Co-Director (if applicable) and the Director of Undergraduate Studies. Please check the Department's webpage for guidelines.

SUPERVISION

The Honors Thesis will be written under the Supervision of the Director (within the Department of Hispanic Studies) and Co-Director (within or outside the Department of Hispanic Studies, if applicable).

COURSE DESCRIPTION

This independent research course leads to an undergraduate thesis in Hispanic Studies (research thesis, technology-based project, translation project) on topics dealing with Spanish and/or Latin American studies, literature, culture, civilization, visual studies, Hispanic linguistics, or the teaching of Spanish.

This course can be counted toward total credits in the major in Spanish, much like any other 300+ or 400+ credit course.

O IVO

The goal of this course is to give the outstanding students in the major the opportunity to further their education by seeking, discovering, and crearting in their field through an independent research project.

The Honors Thesis

THESIS

The Honors Thesis must be written in Spanish and be between 35-45 pages in length including bibliography.

STEPS FOR THE THESIS

- outline the preliminary bibliography (including materials in the target language) to be approved by the Director
- 2 complete draft
- approval of the final version by the director (and Co-Director if applicable)
- presentation of the Honors Thesis in a student/faculty forum

REPORTING THE RESULTS

Upon completion of the thesis, the faculty director and the student sign a final report cover sheet.
